

**ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM**

I hereby assume all of the risks of participating in any/all activities associated with this **Sujoy Spencer's Music Studio** for myself and my family members including minor children, including, by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that we are physically fit and certify that there are no health-related reasons or problems which preclude our participation in this activity.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in which we are participating, and that it will govern our actions and responsibilities at said activity.

In consideration of our participation in this activity, I hereby take action for myself, my family, including minor children, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in these paragraphs from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

I acknowledge that the Organizers and the Hosts and any representatives or agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

I acknowledge that participation in this activity, though unlikely, may involve injury or property loss. The risks include, but are not limited to, those caused by facilities and/or actions of other people including, but not limited to, participants, Hosts and/or Organizers of Sujoy Spencer, Richard Thorlakson and 7344 N 22<sup>nd</sup> Place, Phoenix AZ 85020.

**I certify that my minor children will be fully supervised at the Hosts' home and the Hosts will not be liable for any injury caused by use of equipment or pool.**

I hereby consent, on behalf of my family, to receive emergency medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.
